① Detailed Description of goods

Please input accurate and specific descriptions of goods in "Nature and Quantity of Goods" of MAWB and HAWB, FWB and FHL.

Accessories	Bathroom Fittings, Lightning and electrical accessories
Auto Parts	Automobile Blakes, Windshield Grass for Automobiles
Garments	Cotton T-shirts, Silk headscarves
Household goods	Plates, Dishes, Tableware,
Machine Parts	Pump, Seals, Engines

② Shipper/Consignee Information

Please submit the correct name and address of Shipper/Consignee without omission. We have seen many cases where either ZIP/Postal Code and/or 2 digits of Country Code are missing.

2. Notes for ICS2(Import Control System2) requirements

In addition to the above Notes, please follow ICS2 requirements to comply with the customs rule in EU, Norway and Switzerland. (excluding the UK.)

(1) Applicable Cargo

All cargo to/via EU, Northern Ireland, Norway and Switzerland, (excluding the UK)

(2) Points to be close-checked

- ① 6-digit HS Code (Harmonized System Code)
- ② Consignee's EORI (Economic Operator's Registration and Identification Number)

(3) How to submit

① 6-digit HS code (Harmonized System Code)

Please see below examples of inadequate Input and Invalid Submission.

- Blank Field (HS code itself is missing or missing in FWB for Cosolidated shipment)
- Using Invalid HS code number
- Including HS before the 6-digit number (ex. HS123456)
- Adding space in between the 6-digit code (ex. 12 34 56)
- Adding unnecessary symbols (ex. 12.34/56)
- Using Abolished HS code (old version)
